NC Forest Service Helene Funding



HOUSE BILL 1012

Signed June 27th, 2025

SECTION 2A.3.(a)

c. Fifteen million dollars (\$15,000,000) for the North Carolina Forest Service for wildfire assets and preparedness, including contract services and equipment to respond and fight wildfires in the affected area.



Helene Wildfire Funding Breakdown





Equipment

\$7.7 million

- Examples include bulldozers, truck tractors, trailers, Initial Attack wildland engines, support vehicles and supplies to outfit wildland engines
- Wildfire Support Services \$7.3 million
 - These funds are reserved for large wildfires and severe wildfire conditions in the Helene Impacted area.
 - Examples include expenses related to moving resources into the affected area to support wildfire efforts.

Other Wildfire Efforts USDA Disaster Relief Block Grant





- \$221 million
- Categories of eligible losses
 - Infrastructure Damage
 - Market Loss
 - Future Economic Loss
 - Timber Loss
 - "Timber Loss Relief Program"
 - Will provide a loss payment to eligible timber producers based on a percentage of the damage



Major recovery efforts underway

Rebuilding Safe Housing

- Residents received \$542M+
 in FEMA Individual
 Assistance
- 6,900 households received temporary housing
- 6,300+ applications received for HUD single-family housing program
- 550+ homes repaired by volunteer organizations such as Baptists on Mission and Habitat for Humanity with state funds

Restoring our Infrastructure


- 7m+ cubic yards of right-ofway debris removed
- 8.3m+ cubic yards of waterway debris removed
- All site assessments (more than 6,500 in total) completed in State's Private Roads & Bridges Program
- \$33.5M in FEMA funds authorized to repair private roads and bridges

Revitalizing our Economy and Communities

- \$55M in state and philanthropically funded small business grants fully disbursed, with more than 2,100 recipients
- \$418M+ in SBA loans offered
- \$39M+ in disaster unemployment assistance distributed
- \$148M+ in loans offered to 90 local governments



NC Department of Transportation has reopened more than 98% of state roads (97.8% fully reopened, 1% partially reopened)





Select State Program Updates



Over \$500,000 Announced for Home and Temporary Housing Winterization Efforts

Governor Stein, GROW NC, and NC Emergency Management announced \$500,000 in grants to Rebuild Haywood and the WNC Conference of United Methodist Churches to complete emergency repairs and temporary measures to prepare homes damaged by Hurricane Helene for winter.

In addition, GROW NC announced nearly \$50,000 to The Beacon Network and Rebuild Haywood to support their work to winterize campers, trailers, and other temporary housing for families displaced by Helene.






WNC Thrive Program Launches to Support Children, Youth, and Families

WNC Thrive expands resources for children, youth, and families affected by Hurricane Helene. The program helps young people heal, reconnect, and thrive through safe, supportive, engaging activities—all at no cost to families.

WNC Thrive works with multiple organizations to offer afterschool, weekend, and summer camp programs to children and families recovering from Hurricane Helene. All activities are free for eligible participants living in one of the 22 hurricaneaffected counties Vaya serves.

DEQ Announced \$270 Million for Resilient Water Infrastructure Projects in Areas Impacted by Hurricane Helene in December

- The awards fund 54 water, wastewater and septic system projects across 26 counties as part of a U.S. Environmental Protection Agency program for disaster-affected states.
- North Carolina is the first state impacted by Hurricane Helene to make awards from this program
- The drinking water and wastewater award funds are directed to improve flood resilience in systems that were impacted by Helene, and septic system funds must be used to improve flood resilience to septic systems in Helene-affected areas.



75 Grants to Repair Infrastructure in Western NC Supporting Local Governments with Ongoing Hurricane Helene Recovery

- Announced by Governor Stein on Dec. 15
- Nearly \$50 million in grants will support local governments in western North Carolina in their recovery efforts.
- The grants, administered by the Office of State Budget and Management (OSBM), provide critical funding to repair, renovate, or replace storm-damaged infrastructure.
- OSBM received 172 applications totaling over \$100M in needs.



- The Helene Local Government Capital Grants Program was established when the General Assembly provided nearly \$50 million in state funds to local governments in FEMA-designated disaster areas.
- Eligible projects for this program were ineligible for or denied FEMA Public Assistance reimbursement, and priority was given to communities with populations less than 300,000.



Deadline Extended to Dec. 31: Grants for Volunteer Organizations Active in Housing Repairs & Rebuilds

Phase 2 of \$28 million appropriations for nonprofit volunteer organizations aiding rebuild and reconstruction efforts in WNC. More than \$9M was awarded to 14 nonprofits in October.

Eligibility: Volunteer organizations actively involved in actual and ongoing repair and reconstruction projects for homeowners affected by Helene.

*Organizations do <u>not</u> need to be a member of NCVOAD.

Deadline: December 31, 2025 (no later than 5 PM)

Applications Remain Open - Private Roads and Bridges Reimbursement Program

The application window is open for reimbursements through the NC-PRB program for private road and bridge repairs that are already completed.

Part of \$25M appropriation from the NC General Assembly. Reimbursements are permitted to cover up to 50 percent of a project's total cost.

Agriculture Disaster Crop Loss Program

\$63 million distributed by the NC Department of Agriculture for crop losses resulting from Hurricane Helene. The Department hopes to complete crop payments by the end of the calendar year and begin payments for infrastructure losses in the new year.

The General Assembly appropriated nearly \$240 million for Helene impacted counties. The application window for these funds closed in May.






Streamflow Rehabilitation Assistance Program (StRAP) Applications Open for Round 1 Eligible Counties

Funding to repair stream damage caused by Hurricane Helene. StRAP has \$38M available for grants over multiple rounds (by eligible county groupings). Soil & Water Conservation Districts, political subdivisions (city/county govt., water/sewer district, sanitary district, etc.), and nonprofit organizations are eligible to apply.

Deadline for Round 1 counties: 5pm, February 6, 2026 (additional application windows will be announced)



Grant Funding to Support Recycling and Waste Reduction in WNC

Supports WNC communities in rebuilding and strengthening waste reduction and recycling systems following Hurricane Helene. The program provides up to \$25M in grants over multiple phases.

Eligibility: Local governments may apply for up to \$5M per project, with no local match. Eligible projects may include but aren't limited to:

- Construction or improvement of recycling or composting facilities;
- Development of regional collection (hub-and-spoke) systems;
- Upgrades to convenience centers or household hazardous waste programs;
- Purchase of recycling trucks, containers, or carts;
- Related feasibility studies or education and outreach

Deadline: January 30, 2026

Free Grant-Writing Assistance Available

The NC Department of Environmental Quality (DEQ) launched the Western NC Recovery Grants Program to help communities affected by Hurricane Helene rebuild and secure long-term recovery funding.

The program provides free grant-writing and technical assistance to towns, counties, councils of government, and eligible nonprofits across the 39 federally declared disaster counties in western North Carolina and the Eastern Band of Cherokee Indians.

The program will remain open throughout the year, and there is no formal deadline to apply for assistance.





New Parks and Recreation Grants Available Through Helene Recovery Fund

- The Helene Recovery Fund provided through the Parks and Recreation Trust Fund (PARTF) offers dollar-for-dollar matching grants to local governments for the acquisition and/or development of park and recreational projects to serve the general public.
- Projects must be on a single site.
- No maximum award amount is specified.
- Submit applications by 5 PM on January 30, 2026.



Applications Open for NC Small Business Infrastructure Grants

Part of \$55M appropriation from the NC General Assembly to assist small businesses by expediting infrastructure repairs impacting the operation and patronage of small businesses in the affected area.

Nearly \$32 million remaining; max award per project: \$1 million.

Eligibility: Local governments impacted by Hurricane Helene and designated under a major disaster declaration from Helene. Special consideration given to local governments in Tier 1 and Tier 2 Counties.

Timeline: Applications accepted on a rolling basis; awards announced:

- June 30, 2025 \$7.3m <u>announced</u>
 November 12, 2025 –\$13.8m announced
- February 28, 2026 (anticipated)
- June 30, 2026 (anticipated)



2026 Economic Development Tier Rankings Released

Annual assignment of each county by the NC Department of Commerce to a designation of Tier One (most distressed), Tier Two, or Tier Three (least distressed).

Of the eighteen counties statewide that will change tiers in 2026, eight are in the Helene region:

In addition to being used as a broad indicator of a county's economic status, the system is used as scoring criteria for various state grant programs, including determining eligibility and determining the amount of local grant match.



Select Federal Program Updates

EDA Disaster Supplemental Grant Program -\$1.45B in Economic Recovery Funds

Funds open to all 2023 & 2024 federally-declared disaster zones

First come, first served – EDA encourages applicants to work with their local Economic Development representatives to submit competitive projects ASAP

80% EDA funded / 20% cost share from applicant

Eligible Entities include units of government, economic development districts, institutions of higher education, and nonprofits working with local government

GROW NC seeking to increase the # of proposals from NC

- Working directly with communities to develop projects and encourage timely applications
- Additional \$6M in State Helene aid for local government capacity to assist with EDA and other applications

Three Funding Pathways

- READINESS PATH Capacity building and strategic planning projects that set the stage for future investment
 - Max award: \$500,000
 - No application deadline
- IMPLEMENTATION PATH Standalone construction and non-construction projects that help communities recover from natural disasters and advance recovery and growth
 - Max award: \$20m
 - No application deadline
- INDUSTRY TRANSFORMATION PATH –
 Coalition-led, multi-project portfolios that
 transform regional economies through
 targeted industry development
 - Max award: \$50m
 - Application deadline: March 3, 2026
