# Major recovery efforts underway

## Rebuilding Safe Housing

- Residents have received \$440M+ in FEMA Individual Assistance
- 6,000+ households have received temporary housing
- \$1.4 billion HUD action plan approved, unlocking funding for housing and other projects
- Partnering with volunteer organizations such as Baptists on Mission and Habitat for Humanity to jumpstart rebuilding efforts

## Restoring our Infrastructure

- Right-of-way debris removal nearly complete
- Waterway debris removal underway
- >95% of WNC public roads have access restored
- State Private Roads & Bridges Program open for applications
- \$21.5M in FEMA funds already disbursed for private roads and bridges

## Revitalizing our Economy and Communities

- \$55M in state and philanthropic funded small business grants fully disbursed, with more than 2,000 recipients
- About \$358M in small business loans offered
- \$37.8M+ in disaster unemployment assistance distributed
- \$32M+ in loans to local governments

# Small Business Infrastructure Grant Program

\$55M allocated in SL2025-2

**Purpose:** "to assist small businesses by providing grants to local governments to expedite infrastructure repairs impacting the operation and patronage of small businesses in the affected area"

**Status:** The Rural Economic Development Division (REDD) of the Department of Commerce announced the launch of the program on April 29.

**Timeline for Awards:** There will be a continuously open grant window; awards will be announced on or before the following dates:

- June 30, 2025
- October 31, 2025
- February 28, 2026
- June 30, 2026

**Eligibility:** local governments impacted by Hurricane Helene and designated under a major disaster declaration as a result of Hurricane Helene. Special consideration will be given to local governments in Tier 1 and Tier 2 Counties.

**Max Grant Award:** \$1M

# North Carolina's Ag Disaster Crop Loss Program

*State source of funding: The Disaster Recovery Act of 2025 – Part 1*

- NCGA Appropriation: \$200m for a one-time assistance program
- Offers assistance to agricultural producers who suffered verifiable losses from any declared agricultural disaster in 2024
- Deadline for applications was May 4, but still accepting applications until May 19 under expectation that General Assembly will approve requested extension.
- Applications from WNC farmers lower than anticipated as compared to eastern North Carolina farmers

# North Carolina Emergency Management is accepting interest forms for assistance with private roads and bridges

## *State source of funding:*

- NCGA Appropriations: \$100m with requirement that NCEM seek federal reimbursement when possible

## *Program details:*

- Works to make robust use of federal dollars
- Prioritizes repairs to private roads / bridges that are the **sole access for emergency services to residential properties** occupied by the property owner for over six months of the calendar year
- Prioritizes repairs to private roads / bridges providing access to multiple residential homes, recreation or commercial facilities

U.S. Department of Housing and Urban Development moves \$1.4 billion CDBG-DR grant forward for western North Carolina

RALEIGH, NC

Governor Josh Stein announced today that the U.S. Department of Housing and Urban Development (HUD) has approved North Carolina's Action Plan for a \$1.4 billion grant to help western North Carolina rebuild following Hurricane Helene. When compared to other states' performance over the past decade, North Carolina submitted its Helene Action Plan to HUD in the [shortest](#) amount of time following a major hurricane.



- The U.S. Department of Housing and Urban Development (HUD) approved North Carolina's Action Plan for a \$1.4 billion grant to help western North Carolina rebuild following Hurricane Helene.
- North Carolina submitted its Helene Action Plan to HUD in one of the shortest amounts of time of any state following a major hurricane.
- Approving the Action Plan was the required next step for North Carolina to receive federal funds from the CDBG-DR grant award, which was first announced in January.
- Once HUD certifies the state's financial controls for the program, North Carolina can sign the grant agreement and begin committing these funds with a focus on housing and economic revitalization.

# Governor Stein Appeals FEMA Decision Not to Renew 100% Match

## Governor Stein Appeals FEMA Decision to Not Renew 100% Match

RALEIGH, NC

Governor Stein today appealed to President Trump, asking him to overturn FEMA's [decision](#) not to extend its 100 percent match for eligible Helene costs.

"Hurricane Helene caused incredible damage to western North Carolina. President Trump, as you noted when you visited the region in January, we need a focus on debris removal to create a clean slate from which we can effectively rebuild," **wrote Governor Josh Stein.** "I therefore respectfully urge you to reconsider FEMA's regretful decision and extend our 100 percent cost share period for six months – failing that, then for three months. Doing so would allow us to continue to build on the momentum you have helped us achieve."

- FEMA denied North Carolina's request for a six-month extension of 100% cost-sharing for Hurricane Helene recovery efforts.
- The state appealed the decision on April 25, arguing the 100% reimbursement is crucial for debris removal and public works restoration.
- The state is now seeking a three-month extension if the six-month request is not granted.
- Without the extension, FEMA's match drops to 90 percent. **Preliminary estimates have projected a cost to the state of up to \$200 million.**
- Senator Tillis, Senator Budd, Rep. Murphy, Rep. McDowell, and Rep. Davis submitted a letter in support of North Carolina's appeal.

# USDA Emergency Watershed Protection Program

**Local governments may apply as a sponsor for the USDA/Natural Resources Conservation Service's (USDA-NRCS) Emergency Watershed Program (EWP).**

This program is designed to relieve imminent hazards to life and structures/infrastructure caused by natural disasters. Project examples include debris removal from stream channels, road culverts, bridges, streambank restoration, drainage repair, and floodplain easements.

The non-federal match has been waived for project sponsors for Helene-impacted projects in NC.

A project sponsor can be a legal subdivision of the state, such as a state agency, county, city, town, soil and water conservation district, or an Indian Tribe or a Tribal organization.

# USDA Supplemental Disaster Assistance for Agricultural Producers

Timeline released on May 7 - [2023/2024 Supplemental Disaster Assistance | Farm Service Agency](#)

- **General Block Grant Authority**
  - NC Department of Agriculture & Consumer Services submitted initial proposal for more than \$500 million to USDA
  - NC should have fully executed agreement complete by June 30, 2025.
- **[Emergency Commodity Assistance Program \(ECAP\)](#)** provides economic loss assistance for covered commodities based on 2024 planted and prevented planted acres.  
Deadline: **August 15, 2025**
- **Supplemental Disaster Relief Program** (for producers with indemnified losses)  
Target date for sign-up to begin: **July 7, 2025**
- **Emergency Livestock Relief Program (ELRP) for Flooding**  
Target date for sign-up to begin: **August 18, 2025**
- **Supplemental Disaster Relief Program** (for producers with uncovered/shallow losses)  
Target date for sign-up to begin: **September 15, 2025**

Total number of AmeriCorps NC members: 202

**8 out of the 19** AmeriCorps NC programs are on the list of terminations.

**25 members** focused on conservation at **Conserving Carolina**.

**14 members** serving as Academic Enrichment Specialists or Community Resource Specialists in **Buncombe County**.

**9 members** building and maintaining community gardens in **Beaufort County**.

The cuts come after **52 AmeriCorps National Civilian Community Corps members focused on Helene recovery** were recalled earlier this month in North Carolina. Members were working with the United Way of Asheville Buncombe County, Asheville Area Habitat for Humanity and other organizations.

On April 29, State Attorney General Jeff Jackson **filed suit against AmeriCorps**, accusing it of unlawfully **halting grants** approved by Congress for **Hurricane Helene recovery**.



- **Dislocated Worker Grant Program:** \$10M appropriated by federal government; \$2M received, \$4M more obligated on May 1

### US DEPARTMENT OF LABOR AWARDS \$4M IN FUNDING TO CONTINUE DISASTER-RELIEF JOBS, TRAINING FOR NORTH CAROLINIANS AFFECTED BY HURRICANE HELENE

**WASHINGTON** – The U.S. Department of Labor today awarded incremental funding of \$4 million to support disaster-relief jobs and continue employment training for North Carolina residents harmed in September 2024 when Hurricane Helene brought the worst flooding in a century to the area.

In October 2024, the department's [Employment and Training Administration](#) responded by awarding a National Dislocated Worker Grant of up to \$10 million, [with an initial award of \\$2 million](#), to assist with cleanup and recovery activities in 25 North Carolina communities affected by the storm.

This [Disaster Recovery National Dislocated Worker Grant](#) allows the North Carolina Department of Commerce, Division of Workforce Solutions to provide people with temporary jobs focused on cleanup and recovery efforts, as well as providing employment and training services to storm survivors.

# What is the Hazard Mitigation Grant Program (HMGP)?

- HMGP is focused at providing **post-disaster assistance** while simultaneously reducing risks to individuals and property from future disasters.
  - HMGP is only available after a Presidential Declaration
  - HMGP is normally offered statewide versus just restricted to disaster area
  - HMGP focus is to ensure governmental actions incorporate critical mitigation measures reducing risk during post-disaster reconstruction
  - Focused at breaking the cycle of damage, reconstruction, and repeated damages
  - Specific Focus Areas:
    - Community-wide risk reduction projects
    - Improving resilience of key infrastructure and resource life-lines
    - Encouraging conservation of the floodplain
    - Increasing future mitigation planning


# Eligibility for HMGP

- Unlike other federal assistance programs, individuals (property and business owners) or private nonprofits (with some exceptions) may not apply directly for HMGP funding. It is the role of the State or federally recognized tribe to apply for and manage implementation funding
- Eligible Sub-Applicants:
  - State agencies
  - Local governments
  - Federally recognized tribal governments
  - Private nonprofit organizations
- Project Application Requirements:
  - Applicants must have an active FEMA-approved and State ADOPTED hazard mitigation plan
  - Sub-Applicants must have an active FEMA-approved and local jurisdiction ADOPTED hazard mitigation plan
  - The mitigation project being proposed **MUST** be listed in the State's and local jurisdiction's active hazard mitigation plan
  - Have a beneficial impact in the designated disaster area
  - Conform to 44 CFR part 9. Floodplain Management and other environmental and historic preservation laws
  - Solve a problem independently
  - Be Cost effective (achieve a Benefits Cost Ratio (BCR) of 1 or greater)

# Available Funding and Funding Use

- Amount of Funding for HMGP is based on amount of the aggregate grant amount made for the major disaster
- NC is an Enhanced State and therefore receives 20% of the aggregate grant amount
- Final HMGP total budget for the State is 20% of the aggregate amount calculated on the 1-year anniversary of the incident date
- FEMA will issue a lock-in letter that informs the State of the overall HMGP amount and breaks down the amount for project funds, planning funds and initiative funds.
- Management and sub-recipient costs are also made available, which increases overall award amount by 15% (10% to State and 5% to each sub-applicant).
- Funding is broken down into 3 categories
  - Project Funds – 88% of the total HMGP funding amount (Can be used for allowable projects, must have a BCR)
  - Planning Funds – 7% of the total HMGP funding amount (Supports plan development like Hazard Mitigation Plans)
  - Initiative Funds – 5% of the total HMGP funding amount (typically used for projects that would NOT be able to pass the required BCR of 1 or greater)
  - Example:
    - Total Storm Value - \$1,000,000.00
    - HMGP Total Value (NC) - \$200,000
    - Project Funds - \$176,000
    - Planning Funds - \$14,000
    - Initiative Funds - \$10,000
- Planning and Initiative funds can be moved to the project fund category if not needed/utilized, but planning and initiative funds can not exceed 7% or 5% respectively.





# HMGP Project Types and Time Expectations

- The HMGP possess the capability to carry out a multitude of projects
- The HMGP program timeline is NOT fast, due to size/scope/number of the projects and federal; review/approval process
- General HMGP Timeline is:
  - Application period (for State’s applications) – 15 months
  - Period of Performance (POP)– 48 months from close of application period; extendable up to 36 months
- The bigger the project(s) (i.e. the more homes to be completed) the longer residents may wait to see the actual work performed on their home

# Program Implementation Methods

## Traditional

- Used for Disaster and Non-Disaster Programs
- The sub-recipient is normally a County or a City
- The sub-recipient is responsible for hiring a contractor, doing the work, reporting on the work, expending the funds, and closing out the project
- NCEM provides technical assistance, subject matter expertise, and program oversight

## State Centric

- Post Florence, proposed to FEMA to create a new method of delivery to minimize the financial and administrative burden on local jurisdictions
- Jurisdictions can opt in and State executes work on behalf of jurisdiction
- City or County maintains communications with the homeowners and allowed to draw management costs
- Allows NCEM to complete the project work on behalf of the sub-recipient directly (elevation, acquisition, generator.)
- Concept only available for limited storms at this time, not non-disaster programs





# NCEM State Centric Program

- Intended as full-service support to all State sub-applicants; Sub-Applicants choice to Opt-In or self-perform the awarded application.
- NCEM assists in preparing sub-applicant applications to FEMA – requires Chairman, Board of Commissioners or City Council, or designated agent (DA) to sign the final application
- NCEM contracts and oversees approved applications, expending State funds and pulling down Federal reimbursement (no local funds committed)
- NCEM closes out approved awards with FEMA and provides notification to jurisdiction project closed
- NCEM acts on behalf of the county to process/get approved any Land Leases of acquired properties







General area that could potentially be affected by future debris flows and/or debris slides




Flow ends at  $3^\circ$  slope or 500-year flood plain









# Landslides and Storm Events in Western North Carolina

**1876-2024 148 years**

- **6 events: 100s of landslides**  
Avg. Frequency = 24.7 years
- **3 events: 1,000s of landslides**  
Avg. Frequency = 36 years
- **9 events: 100s-1,000s of landslides**  
Avg. Frequency = 16.4 years
- **Back-to-Back Storm Events**  
2-12 days apart 1916, 1940, 2004, 2018, 2024
- **6 Events - Multi-state Impacts**


## Rainfall Thresholds for Landslide Activity

- **≥3 inches / 24 hours:**  
Landslides on some constructed slopes with high antecedent moisture
- **≥5 inches / 24 hours:**  
Scattered landslides on constructed and forested slopes
- **≥10 inches / 24 hours:**  
Widespread landslides on constructed and forested slopes

# Landslides in Western North Carolina

## Since 1879 and prior to Helene

- 84 landslide fatalities - 22 injuries
- > 84 homes destroyed - condemned
- > 60 homes damaged
- >> \$53+ million in direct losses
- Ongoing threats – damage to regional infrastructure



## Helene Only

- 24 landslide fatalities – unknown # of injuries
- > 350 homes destroyed - condemned



# Landslide Hazards Program – Issues

## ➤ Issues

1. Not enough resources to quickly map, model, and respond to landslides immediately after events
2. Landslide mappers are not formally trained for emergency response
3. Landslide mappers not formally trained in assessing immediate vulnerability or remediation
4. Required rainfall thresholds are not used when looking directly at susceptibility maps
5. No dynamic and time relative susceptibility maps with precipitation forecast and antecedent soil moisture

# Landslide Hazards Program – Solutions

## ➤ Solutions

### 1. Landslide Mapping Program Expansion

#### ➤ 4 teams of 3 members

- Landslide Emergency Response Team trained in first response
- Landslide Assessment Team (Geotechnical Engineers) to address inquiries and support Emergency Response Team
- 2 dedicated Landslide mapping and modeling teams
  - i. Response and Assessment teams map landslides when not responding to events
  - ii. All teams perform outreach and education

# Landslide Hazards Program – Solutions

## ➤ Solutions

### 2. WNC Landslide Early Warning System

- Required rainfall amounts for landslide initiation added to susceptibility maps
- Dynamic and time relative susceptibility maps with precipitation forecast and antecedent soil moisture
- v.1 in one year with project funding approval
- Project completed with AI automation in 3 years
- ✓ Increased trust in the warning system by reducing false positive advisories

# Landslide Hazards Program – Resilience

## ➤ Actions

1. All WNC County susceptibility models completed within 2 years, landslide inventory mapping continues as long as storms and gravity occur.
2. Every WNC County Planning, Development, Public Relations, and Safety department, educated on how to use landslide inventory and susceptibility maps in 2 years. This will be continuous and in perpetuity.
  - During Helene: County entities did not know how to use existing landslide hazard maps
  - Ordinances: Some Counties have steep slope ordinances, none have mountain stream setbacks
  - Critical Infrastructure: Current hazards to, and future placement of, critical infrastructure, schools, hospitals, power, water, etc.
3. WNC Structural (buildings) landslide vulnerability and risk assessment completed within 2 years.
  - Dynamically determine landslide risk to critical infrastructure during storm events

# Landslide Hazards Program – Resilience

## ➤ Actions

4. Emergency Management/Services focus resources and notices to high susceptibility areas that include required precipitation.
  - Increase map comprehension
  - Reduce response time
  - ✓ Increased public trust in advisories by reducing false positives
  
5. Counties/Municipalities can, as the weather situation changes, dynamically:
  - i. Safeguard critical infrastructure
  - ii. Issue evacuation/recall notices
  - iii. Establish escape/recall routes









Months after initial disruption for visitor spending to return to baseline










# VACATION RENTAL OUTLOOK









**Polarity of social conversations** (100/+100)


■ % Natural Disasters in total Conversations — Destination Net Sentiment Score
