SUBJECT: Quarterly Report on Implementation of the Disaster Recovery Act

Enclosed, please find a report on the uses of Helene disaster recovery and assistance funds for the first quarter of calendar year 2025, as required by N.C. Sess. L. 2025-2, Sec. 4.1.(g)-(h), which reads in relevant part:

Allocation Reporting Requirements. — Beginning May 15, 2025, for the previous quarter, OSBM shall report to the chairs of the House of Representatives and Senate Appropriations Committees and to the Fiscal Research Division of the General Assembly on the implementation of this act on a quarterly basis until the end of the quarter in which all funds are expended and shall also provide any additional reports or information requested by the Fiscal Research Division. In reporting on the use of State disaster recovery and assistance funds expended pursuant to this act and federal funds received by State agencies for disaster relief and recovery efforts, OSBM shall include, regardless of which State agency, federal agency, or non-State entity that administers the funds, all of the following for each program:

- (1) The purpose of the program.
- (2) The responsible department or agency.
- (3) Current, year-to-date, and total cumulative funds appropriated, receipted from non-State sources, expended, encumbered, and obligated by program and by source of funds.
- (4) A summary of activities.
- (5) The total program spending by county, where practicable.
- (6) Funds returned to the Savings Reserve pursuant to subsection (c) of this section, as applicable.

Governor Stein directed the Governor's Recovery Office for Western North Carolina (GROW NC) to fulfill the Executive Branch's reporting requirements regarding the use of disaster relief funds. Accordingly, GROW NC authored the enclosed report on behalf of the Office of State Budget and Management (OSBM).

# INTRODUCTION

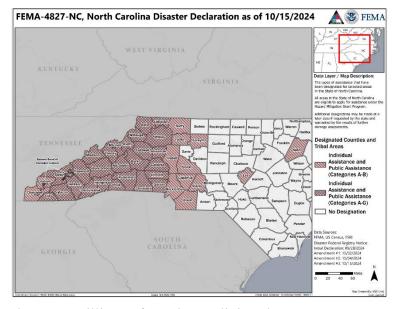
This report provides an overview of the state and federal funds dedicated to Hurricane Helene relief and recovery efforts through March 31, 2025, and how North Carolina is using those resources to aid affected communities, as required by <u>SL 2025-2 (HB 47) § 4.1(g-h)</u>. Unless otherwise noted, this second quarterly report encompasses activities from the onset of the storm through March 31, 2025.

# Hurricane Helene's Impact - \$59.6 Billion

Hurricane Helene reached North Carolina on Friday, September 27, 2024, generating historic rainfall, strong winds, landslides, and tornadoes, among other weather impacts.

The President of the United States subsequently declared a Major Disaster, and FEMA designated 39 counties for federal disaster assistance. An estimated 4.6 million people – more than 40% of the state's population – live in one of the designated counties. The region accounts for 45% of the state's GDP.

Hurricane Helene had a significant, long-term impact on western North Carolina. In addition to the devastating loss of more than 100 lives, the storm destroyed thousands



of homes and damaged tens of thousands more. Millions of North Carolinians lost access to critical services such as water and sewer, electricity, telecommunications, and health care facilities. Thousands of miles of roads and bridges were damaged, cutting communities off and limiting access for residents, first responders, and recovery teams. The region's economy has suffered a severe blow, threatening livelihoods and the long-term outlook of some communities.

Estimates as of December 13, 2024, indicated that Helene caused direct damages of \$44.4 billion in the region, caused an additional \$9.4 billion in indirect or induced damages, and necessitated \$5.8 billion more for strengthening and mitigation. Totaling more than \$59.6 billion across the

state, these damages and needs are more than three times the \$16.7 billion impact of Hurricane Florence in 2018.

# Government Funding for Recovery Efforts - \$5.95 Billion

As of March 31, 2025, the federal government and North Carolina state government had directed approximately \$5.95 billion—about 10% of the estimated impact of the storm—to aid western North Carolina communities in the wake of Hurricane Helene, including roughly \$1.57 billion appropriated by the North Carolina General Assembly, at least \$261 million in existing state operational resources redirected toward response and recovery efforts, \$1.4 billion in federal direct assistance to individuals and communities, and approximately \$2.7 billion in federal grants.

## \$1.57 Billion in state funds had been appropriated as of March 31, 2025.

State agencies are working to deploy funding effectively and efficiently to speed recovery efforts. The total \$1.57 billion in appropriated state funds includes \$325 million for state matching funds to draw down dollars from federal programs and \$272 million for loans to local governments or businesses. Some state appropriations require certain conditions to be met before expenditure. For example, \$120 million was appropriated for the State Home Reconstruction and Repair Program, which the state may begin spending upon completing federally reimbursable contractor procurements.

## North Carolina continued to receive direct assistance from the federal government.

As of March 31, 2025, highlights included:

- **\$415.2** million in FEMA Individual Assistance approved for over 158,000 households and individuals. That includes housing assistance and other critical supports to help families navigate their recovery.
- \$33.8 million disbursed for nearly 9,000 unemployment assistance claims.
- **\$417.3 million** in FEMA Public Assistance funding obligated to support community recovery.
- 235 households placed in direct housing.
- More than 8 million cubic yards of debris removed from public rights of way and waterways as a result of the combined efforts of the state's prepositioned contractors and contractors retained by the US Army Corps of Engineers (USACE).
- \$166.5 million in homeowner and small business loans disbursed. Although most application deadlines have passed, the SBA is still accepting loan applications for Economic Injury Disaster Loans.

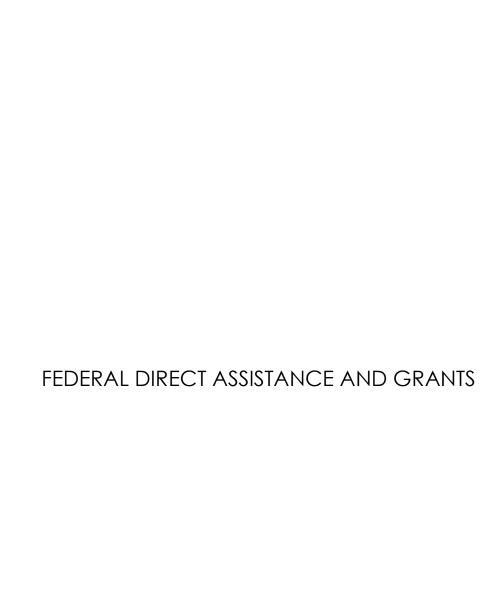
## Congress Passed Additional Relief Funding on December 21, 2024

On December 21, 2024, Congress passed additional federal relief funding to support recovery of communities across the Southeast and Appalachia from Hurricanes Helene and Milton. Federal agencies have or will allocate much of the funding from the more than \$100 billion relief legislation (HR 10545) to states, but many of the decisions about allocation amounts and timelines are still in process. As of March 31, 2025, federal agencies had allocated \$2.7 billion in funding from HR 10545 to North Carolina's Helene recovery efforts. Of this amount, the State of North Carolina has not received at least \$2 billion. For example, on January 7th, the US Department of Housing and Urban Development (HUD) awarded \$1.65 billion to North Carolina: \$1.43 billion to the state and \$225 million directly to the City of Asheville. That funding remains unavailable, however, until the completion of various federally required processes. Similarly, the US Environmental Protection Agency transmitted an implementation memo notifying the state of its decision to allocate approximately \$685 million to the state for water and wastewater repairs. None of these funds have yet been disbursed as various federally required prerequisites are in the process of being met. Future quarterly reports will track new federal funding to North Carolina as awards are made and disbursed.

# Scope of Data Included

This second quarterly report provides an updated overview of Hurricane Helene recovery expenditures and activities to date. The report is based on state and federal programmatic and financial data through March 31, 2025.

Please note that obligations and expenditures for the most recent Hurricane Helene relief session law, S.L. 2025-2, are not included here. The funds appropriated in that law were not certified and made available to state agencies until April 16, 2025, which fell after the March 31, 2025 cutoff date for the data and information included in this report.



# **Direct Housing**

## **Purpose**

Direct Temporary Housing options can include temporary travel trailers or manufactured housing units, direct lease, and multi-family unit leases.

# **Disaster Unemployment Assistance**

#### **FEMA**

Federal Funds Type: Direct Assistance

Recipient: Direct Assistance

## **Purpose**

The Disaster Unemployment Assistance (DUA) program provides financial support to individuals unemployed as a direct result of a federally declared disaster, but ineligible for regular unemployment insurance benefits. In coordination with FEMA, the U.S. Dept. of Labor oversees the DUA program, which is then administered by the NC Division of Employment Security (DES).

#### **Activities**

DES has issued DUA benefits totaling \$33,781,356 to claimants in disaster-declared counties as of March 31st. 8,956 claims have been paid, with an additional 1,971 eligible for payment. 14,315 applications were received as of March 31st. DUA benefits are available for weeks between September 29, 2024 and March 29, 2025, but the application period for benefits was open through April 7, 2025.

# **Hazard Mitigation Grant Program**

#### **FEMA**

Federal Funds Type: Direct Assistance

Recipient: State and Local Governments

## **Purpose**

The FEMA Hazard Mitigation Grant Program (HMGP) aims to reduce the long-term risks to people and property from future disasters. The program provides grants to state, local, tribal, and territorial governments to implement cost-effective measures that minimize disaster damage, enhance community resilience, and reduce reliance on federal disaster assistance. Eligible projects include infrastructure improvements, property acquisition, flood risk reduction, and community planning. Note: All areas in NC are eligible to apply for assistance from HMGP.

#### **Activities**

FEMA's timeline for accepting the state's HMGP applications is generally 15 months after the disaster. The Period of Performance (POP), or the time in which work is completed, is generally 48 months from the close of FEMA's application period. HMGP applications for the following counties/municipalities have been submitted to FEMA, are being reviewed by the state's hazard mitigation team, or are being reviewed by the county: Buncombe, Transylvania, Henderson, Madison, Yancey, Polk, Rutherford, McDowell, Mecklenburg, Town of Clyde, City of Greenville.

# Individual Assistance: Housing Assistance

Recipient: Direct Assistance

## **Purpose**

The FEMA Housing Assistance program provides financial assistance and direct aid to eligible disaster survivors to repair, replace, or secure temporary housing when their primary residence is damaged or destroyed, but insurance or other resources are insufficient.

## **Purpose**

The FEMA Individual Assistance: Other Needs Assistance (ONA) program provides financial assistance to disaster survivors for necessary expenses such as funeral costs, personal property replacement, cleaning and mold remediation after flood damage, and serious needs not covered by insurance such as equipment for repairs, generators for medical needs, or other essential items required for recovery.

#### **Activities**

As of March 31st, 2025, FEMA has provided a total of \$253,487,680 in direct assistance to individuals and households through the ONA program. Assistance types include: Cleaning & Sanitation, Personal Property Loss, Transportation, Funeral Assistance, Moving and Storage Assistance, Childcare, Medical and Dental Care, Misc. & Serious Needs.

# Individual Assistance: Private Roads and Bridges

Recipient: Direct Assistance to Facility

## **Purpose**

The FEMA Individual Assistance program can help pay for repair or replacement of a road or bridge on private property when it is the only route available to reach a primary home or it is the only access for emergency vehicles.

As of March 31, 11,306 distinct individual and household registrations have reported road and bridge (PRB) damage. 6,884 distinct individual and household registrations have received \$20.1 million. 4,422 distinct individual and household registrations are pending.

## **Public Assistance: Debris Removal**

Federal Funds Type: Direct Assistance

Recipient: Direct Assistance

## **Purpose**

The FEMA Public Assistance program supports debris removal efforts through local applicant-managed projects and US Army Corps of Engineers (USACE)-managed projects. Under FEMA direction, the USACE directly executes or oversees debris clearance and disposal operations in complex or large-scale disasters. Applicant-managed removal is conducted by state, tribal, or local governments, with FEMA reimbursing costs if eligibility requirements are met.

# **Public Assistance: Emergency Protective Measures**

Recipient: Direct Assistance

## **Purpose**

The FEMA Public Assistance program provides reimbursement to local, tribal, and state government agencies for the costs of emergency response, debris removal, and restoration of disaster-damaged public facilities and infrastructure. The program also can reimburse certain private non-profits or houses of worship for response and recovery items. Emergency work funded under FEMA Category B: Emergency Protective Measures includes activities to save lives, protect public health and safety, protect improved property, or eliminate or lessen an immediate threat of additional damage.

#### **Activities**

FEMA has obligated \$178,235,274.40 for 120 projects to North Carolina through the Public Assistance Program for Emergency Protective Measures as of March 31. Emergency Protective Measures are temporary measures taken before, during, and after an incident to save lives, protect public health and safety, and prevent damage to improved public and private property. Examples include firefighting, search and rescue, and evacuation and sheltering.

## **Public Assistance: Other**

Recipient: Direct Assistance

## **Purpose**

FEMA's Public Assistance (PA) program is designed to provide funds to assist communities recovering from federally declared disasters. It supports state, tribal, territorial, and local governments, as well as certain private non-profits, in applying for assistance after a disaster declaration. The program covers emergency assistance to save lives and protect property, as well as funding for restoring community infrastructure affected by disasters. Debris removal and Emergency Protective Measures have been separated out for this report.

# **Transitional Sheltering Assistance**

Recipient: Direct Assistance

### **Purpose**

FEMA's Transitional Sheltering Assistance (TSA) provides temporary accommodations for eligible disaster survivors whose homes are uninhabitable or inaccessible due to a disaster. To qualify, you must have experienced home damage, be unable to return to your home, or have essential utilities out. Housing needs cannot be met by insurance or other assistance. TSA is requested by a state and is designed to offer short-term lodging until more permanent housing solutions are available.

#### **Activities**

Expenditures are not reported for this program. As of March 31, 2025 there were 274 households checked in, occupying 294 hotel rooms. This represents a decrease of 13 hotel rooms since the previous report. Overall 13,022 households have been checked out since November 2024.

# **Unemployment Insurance**

## **US Department of Labor**

Federal Funds Type: Direct Assistance

Recipient: North Carolina Department of Commerce

## **Purpose**

The Unemployment Insurance (UI) program is a federal-state partnership that provides temporary financial assistance to eligible workers who lost their jobs through no fault of their own. State law allows eligible claimants to receive benefits up to \$350 per week, for up to 12 weeks. However, Executive Order No. 322 (issued October 16, 2024), authorized a temporary increase of unemployment benefits to a maximum of \$600 weekly.

NC Division of Employment Security (DES) has issued UI benefits totaling \$56,355,933.19 to claimants in disaster-declared counties as of March 31st. 15,126 claims have been paid, with an additional 4,878 pending. 21,632 claims were filed as of March 31st.

# **Small Business Administration (SBA) Loans**

#### **Small Business Administration**

Federal Funds Type: Direct Assistance

Recipient: Direct Assistance

## **Purpose**

The SBA offers several types of disaster loans, including Home Disaster Loans, Business Physical Disaster Loans, and Economic Injury Disaster Loans (EIDLs). These loans provide financial assistance to help individuals and businesses recover from the impacts of declared disasters. Home Disaster Loans are available to homeowners and renters and Physical Disaster Loans to businesses and non-profits to repair or replace property damaged by a disaster, including real estate, machinery, inventory, and personal belongings. EIDL loans offer working capital to small businesses, agricultural cooperatives, and non-profits that experience substantial economic injury due to a disaster, even if they have not sustained physical damage.

## **Crisis Counseling Immediate Services Program**

### **Purpose**

Crisis Counseling Immediate Services Program (ISP) is a short-term disaster relief initiative designed to provide immediate psychological and emotional support to individuals and communities affected by disasters. FEMA activated ISP to address the mental health needs of residents dealing with stress, trauma, and challenges resulting from the storm's destruction. The NC DHHS Hope4NC Crisis Counseling Program provides immediate support and crisis counseling services at no cost for North Carolinians following Helene via the Hope4NC Helpline.

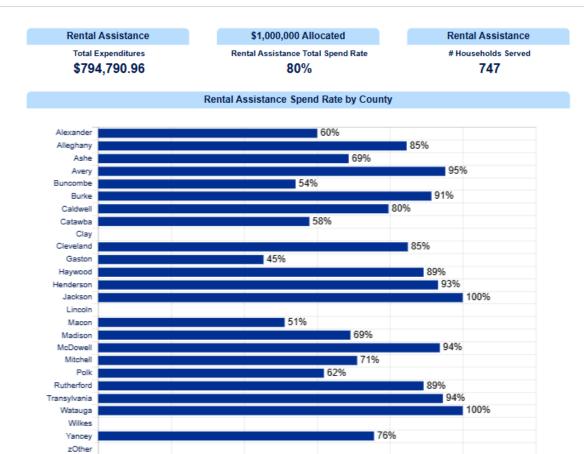

# Mental Health Crisis Supports and Support for Individuals with I/DD

Behavioral health crises tend to increase after the response period and into the recovery period. There has been a continued increase in the number of Helene-impacted constituents seeking mental and behavioral health support. 22 of the 39 eligible counties accepted these funds, while the remaining counties declined funds for reasons such as no disruption or little to no impact on essential public health functions, services, or programs. 100% of the \$12M was allocated and distributed to the 22 accepting Local Health Departments (LHDs) serving a population of 1,177,823. The funding was not split evenly; the amount per county was determined based on a funding formula: 40% of the total was split evenly, and the remaining 60% was allocated as a percentage per county based on the Business Disruption Model and the population in the county. These funds provide financial relief to the LHDs and districts in counties to restore their essential functions and address the post-disaster needs of the local public health system during recovery. Some uses include temporary staffing, communicable disease and infection prevention efforts, environmental health efforts, and private well water quality efforts. Counties received the funds in early January and have until May 31, 2030, to spend them. As of the beginning of March, \$82,936.59 has been expended by the LHDs.

Habitat for Humanity is standing up their program to spend the \$3,000,000 allocation for housing repair and replacement. # State Private Roads and Bridges Repair and Replacement Program

**Department of Public Safety** 

Appropriation: \$100,000,000.00

Enacting Legislation: SL 2025-2

Type of Funds: State Funds

#### **Program Description**

For the repair and replacement of private roads, culverts, pipes, and bridges damaged or destroyed by Hurricane Helene. NCEM shall prioritize applications for the repair and replacement of private roads or bridges that provide the sole option for ingress and egress for (i) emergency services to a residential property that is occupied by the owner for more than six months of the calendar year, (ii) multiple residential homes, or (iii) recreation or commercial facilities. These funds may be used for program costs incurred for the engineering, design, and construction of private roads, culverts, pipes, and bridges, and funding to nonprofit organizations supporting bridge repairs. These funds may also be used to provide technical support and assistance for individuals and local governments to comply with no rise certification requirements required by FEMA under the National Flood Insurance Program.

#### **Activities**

More than 3,000 people have expressed interest through the state's private road and bridge program online interest form. The NC Division of Emergency Management (NCEM) is securing vendors for program management, engineering services, and construction. NCEM has been in communication with those who filled out the interest form to share updates and next steps.

#### **Unmet Needs - Debris and Sediment Removal**

#### Office of State Budget & Management

Appropriation: \$20,000,000.00

Enacting Legislation: SL 2025-2

#### **Program Description**

Funding distributed by OSBM to state agencies and units of local government for debris and sedimentation removal unmet needs. # REDIRECTED STATE AGENCY RESOURCES

In addition to the new state and federal fund appropriations presented above, agencies have redirected significant existing staff time and operational resources toward Hurricane Helene recovery efforts.

Some portion of expenses for these activities will be eligible for FEMA reimbursement. But a significant portion will be borne as state opportunity costs – the effect of redirecting resources away from other activities.
