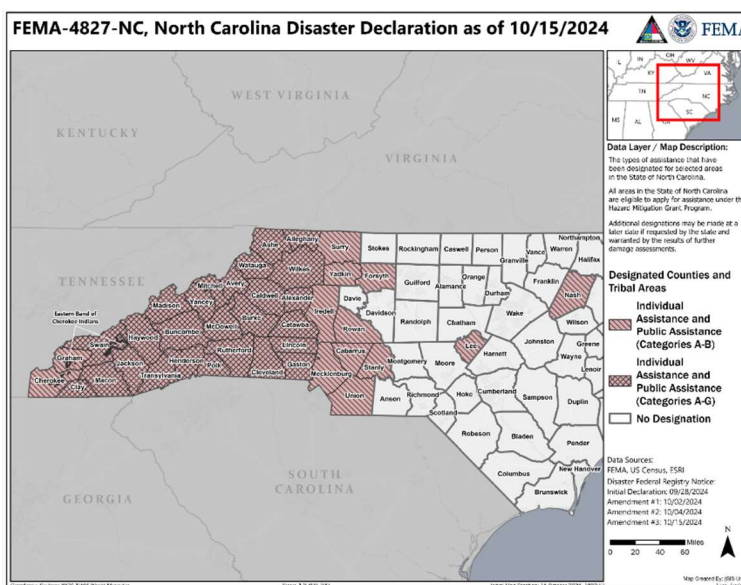

INTRODUCTION

This report provides an overview of the state and federal funds dedicated to Hurricane Helene relief and recovery efforts through June 30, 2025, and how North Carolina is using those resources to aid affected communities as required by [SL 2025-2 \(HB 47\) § 4.1\(g-h\)](#). Unless otherwise noted, this third quarterly report encompasses activities from the onset of the storm through June 30, 2025.

Hurricane Helene's Impact – \$59.6 Billion

Hurricane Helene reached North Carolina on Friday, September 27, 2024, generating historic rainfall, strong winds, landslides, and tornadoes, among other weather impacts. President Biden subsequently declared a Major Disaster, and the Federal Emergency Management Agency (FEMA) designated 39 counties for federal disaster assistance. An estimated 4.6 million people – more than 40% of the state's population – live in one of the designated counties. The region accounts for 45% of the state's GDP.



Hurricane Helene had a significant, long-term impact on western North Carolina. In addition to the devastating loss of more than 100 lives, the storm destroyed thousands of homes and damaged tens of thousands more. Millions of North Carolinians lost access to critical services such as water and sewer, electricity, telecommunications, and health care. Thousands of miles of roads and bridges were damaged, cutting off communities and

limiting access for residents, first responders, and recovery teams. The region's economy has suffered a severe blow, threatening livelihoods and the long-term outlook of some communities.

Estimates as of December 13, 2024, indicated that Helene caused direct damages of \$44.4 billion in the region, caused an additional \$9.4 billion in indirect or induced damages, and necessitated \$5.8 billion more for strengthening and mitigation.¹ Totaling more than \$59.6 billion across the state, these damages and needs are more than three times the \$16.7 billion impact of Hurricane Florence in 2018.

Government Funding for Recovery Efforts – \$7.6 Billion

As of June 30, 2025, the federal government and North Carolina state government had directed approximately **\$7.6 billion** – about 12.8% of the estimated impact of the storm – to aid western North Carolina communities in the aftermath of Hurricane Helene. The state has provided just over **\$2.9 billion** in funding, including roughly **\$2 billion** in new appropriations and **\$508 million** in reallocations of previously appropriated funds by the North Carolina General Assembly, and at least **\$413.8 million** in existing state operational resources redirected by state agencies toward response and recovery efforts. In addition, federal funding totaling **\$1.61 billion** has been disbursed, including **\$1.1 billion** in eligibility-based FEMA funding to individuals, businesses, local government, state agencies, and nonprofits. Another **\$3.1 billion** in federal funding has been awarded to the State of North Carolina but requires additional approval steps before being disbursed to the state.

\$2 billion in state funds had been appropriated as of June 30, 2025.

State agencies are working to deploy funding effectively and efficiently to speed recovery efforts. The total \$2 billion in appropriated state funds includes \$331 million for state matching funds to draw down dollars from federal programs and \$272 million for loans to local governments or businesses. Other state appropriations require certain conditions to be met before expenditure. For example, \$120 million was appropriated for the State Home Reconstruction and Repair Program, which the state may begin spending upon completing federally reimbursable contractor procurements. The remainder of the funds may be spent by state agencies without significant constraints.

Scope of Data Included

This third quarterly report provides an updated overview of Hurricane Helene recovery expenditures and activities to date. The report is based on state and federal programmatic and financial data through June 30, 2025.

Please note that obligations and expenditures for the most recent Hurricane Helene relief session law, S.L. 2025-26, are not included here. The funds appropriated by that law were not certified and made available to state agencies until late July 2025, which fell after the June 30, 2025, cutoff date for the data and information included in this report.

State Funding

As of June 30, 2025 – the end of Fiscal Year 2025 – the North Carolina General Assembly had appropriated to state agencies approximately \$2 billion in new funds, reallocated to agencies another \$508 million in previously appropriated funds, and set aside in reserve but not appropriated to agencies another \$137.2 million for response and recovery efforts related to Hurricane Helene. This amount addresses 4.4% of the total Helene-related damage and need.

The NCGA's most recent act to provide funding for Helene recovery was Session Law 2025-26, known as *The Disaster Recovery Act of 2025 – Part II*, signed into law by Governor Stein on June 27, 2025. This law appropriated almost \$576 million and reallocated \$302 million in state funds for Helene recovery efforts. Although this law was enacted prior to the end of June 2025 and is therefore included in the total appropriation amount, the funds were not made available to state agencies until July 2025, as they were subject to the standard certification process conducted by the Office of State Budget and Management. Thus, those funds could not be obligated or expended during the fourth quarter of fiscal year 2025, and they are not included in this report.

In addition to using the funds provided to them by the NCGA specifically for Helene-related purposes, state agencies have also redirected \$413 million of the funds they received prior to the storm. Some portion of expenses for these activities will be eligible for FEMA reimbursement. But a significant portion will be borne as state opportunity costs – the effect of redirecting resources away from other activities.

Activities

The NC Department of Agriculture and Consumer Services (NCDA&CS) is working to establish two time-limited positions in the Division of Soil and Water Conservation. One position is established and ready to begin recruitment, and the other is being established.

NCDA&CS will also support seven additional positions to be contracted through local soil and water conservation districts. These contracts take effect July 1, 2025, and run through June 30, 2028.

Streamflow Rehabilitation Assistance Program

Enacting Legislation SL 2024-57

Program Description

Funds are appropriated for purposes in the affected area authorized under the Streamflow Rehabilitation Assistance Program (StRAP). StRAP funds projects that help reduce flooding, restore streams, and protect the integrity of drainage infrastructure across North Carolina’s waterways, such as vegetative debris removal, streambank stabilization, stream restoration, and rehabilitation of critical watershed structures.

Golden Leaf - Hurricane Helene Impacted Business Bridge Loans

Enacting Legislation SL 2024-53

Program Description

The allocated funds support a no/low interest loan program for small businesses in areas impacted by Hurricane Helene. Loans are capped at \$100,000 per business, with terms extending no later than June 30, 2030. Interest rates during the interest-only period are capped at 1%, transitioning to a maximum of 6% post-period, with full amortization over the remaining term. New loans under this program must be awarded no later than October 31, 2028.

As of June 30, 2025, 760 loans totalling just over \$44 million had been approved and disbursed and 6,163 jobs had been retained as a result of the loans. The application for loans is still open.

Small Business Infrastructure Grant Program

The purpose of this program is to assist small businesses by providing grants to local governments to expedite infrastructure repairs impacting the operation and patronage of small businesses in the affected area.

Activities

The first Small Business Infrastructure awards were made on June 30, 2025. Nine awards were made, totaling \$7.3 million. Municipalities receiving awards were the Village of Chimney Rock, Town of Clyde, Town of Gamewell, and City of Morganton.

The next announcement of funding disbursement will be made on October 31, 2025.

State Home Reconstruction and Repair Program

Enacting Legislation SL 2025-2

Program Description

A program to get a head start on NC Commerce Division of Community Revitalization's (DCR) housing repair and rebuild program in anticipation of the \$1.4B in CDBG-DR funding coming from HUD. The State Home Reconstruction and Repair Program works to shorten the timeline for home repair and rebuilding following Hurricane Helene.

Activities

This program operates to improve the timeline for single-family housing repair and reconstruction while the state works with federal partners to receive the \$1.4 billion allocation of funds from the US Department of Housing and Urban Development (HUD) for Community Development Block Grants for Disaster Recovery. The program launched on June 16, 2025, under the name of RenewNC, and applications are now open.

The Department of Commerce's Division of Community Revitalization (DCR) has obligated \$81,495,887.42 for the implementation vendor contract for the RenewNC Single Family Housing program. Funds have not been disbursed by DCR yet because DCR has structured the contract to pay for outcomes, not activities. Payments will be made as the vendor meets the milestones set out in the contract. By structuring the contract to award outcomes instead of activities, DCR is choosing a different contracting model than has been used in previous recoveries.

As of June 30, 350 applications had been submitted. Most of the eligible applications were confirmed as Phase 1, Priority 1, meaning that the applicants are in a HUD-identified most impacted and distressed zone and below 60 percent of the area median income.

Underground Storage Tank (UST) Repair Loan Program

Enacting Legislation SL 2024-53

Program Description

Allocates funds to DEQ to provide emergency bridge loans for testing and repair of underground storage tank infrastructure in counties with a federal disaster declaration due to Hurricane Helene.

Activities

SL 2025-26 reallocated \$20 million from this program for other needs. The NC Department of Environmental Quality (NCDEQ) has awarded all of the limited requests for loans that have been submitted. NCDEQ’s Division of Waste Management sent out notice letters to potential loan recipients, visited 35 sites in western North Carolina to meet with owners and operators, and reached out to inform more than 3,800 facilities about the loan program.

Technical Assistance for Assessments and Design

Enacting Legislation SL 2024-53

Program Description

Allocates funds to DEQ to provide technical assistance to local government units in counties with a federal disaster declaration for assessment and design of water and wastewater infrastructure repair, including the feasibility of regionalization.

Activities

Nineteen technical assistance grants have been obligated to local governments for preliminary engineering as part of emergency bridge loans, which could also apply to preparation for the U.S. Environmental Protection Agency’s State Revolving Fund allocation for repair of water infrastructure. Another 14 technical assistance grants have been obligated to local governments to assess and/or design interconnections for resiliency with other local government partners. Weatherization Assistance

Program Description

Funds to supplement existing federal funds for weatherization services in counties with a federal disaster declaration due to Hurricane Helene. Weatherization reduces utility bills and energy costs and increases home safety.

Activities

Funds totaling \$6 million will go to the Western Piedmont Council of Governments to manage “readiness” phase of weatherization, including investments like roof repair, plumbing updates, and ground leveling. The remaining \$4 million is being divided across 10 weatherization providers in western North Carolina. Those weatherization providers have been selected and are in the process of drawing up contracts with the state.

Emergency Loans for Water/Wastewater Infrastructure Repair

Enacting Legislation SL 2024-53

Program Description

The NCGA appropriated \$100 million in new funding to provide emergency bridge loans to local government units in counties with a federal disaster declaration for water and wastewater infrastructure repairs.

Activities

SL 2025-26 reallocated \$25 million from this program. The maximum loan amount is \$3 million. SL 2025-26 also adjusts the loan terms to make them more favorable for local governments.

Child Care Centers and Family Child Care Homes Disaster Relief

Enacting Legislation SL 2024-53

Program Description

This appropriation provides one-time disaster relief grants to eligible child care providers (including child care centers, homes, and Pre-K sites) in the impacted counties and tribal communities. These restricted funds are to be utilized for capital costs, lost revenue, retention, recruitment, repairs, maintenance, or overcrowding expansion.

Activities

NC DHHS has transferred \$5 million of the \$10 million to the North Carolina Partnership for Children, which then enters contracts with local Smart Start Partnerships to manage the application and allocation process for the child care centers. Funds were received by NCPC in late February 2025. As of June 30, these funds have served 1,407 children in 11 of the 21 eligible counties. Local partners have until June 30, 2027, to expend the funds and are working with the centers to determine needs and allocation.

Rental Assistance

Enacting Legislation SL 2024-53

Program Description

Distribution of funds to county departments of social services in counties with a federal disaster declaration to provide rental assistance to households who have suffered hardship due to Hurricane Helene and are facing a housing crisis, such as imminent risk of eviction.

Funds can be used to pay for up to two rent payments per household.

Activities

A total of 854 households received support through this program as of June 30, 2025. All funds have been expended by NC Department of Health and Human Services to county Departments of Social Services and are actively being drawn down. A total of 97% of the funds have reached households so far, and the remaining 3% of funds were expected to be expended by the end of July 2025.

Department of Health and Human Services

Mental Health Crisis Supports and Support for Individuals with I/DD

Enacting Legislation SL 2024-53

Program Description

Provides funds to strengthen behavioral health supports to ensure DHHS Division of Mental Health (DMH) can adequately respond to the expected rise in behavioral health needs of the more than four million individuals in the impacted counties, including crisis care, detoxification, and continued access to telehealth. Following Hurricane Helene, private investment in mental and behavioral health resources helped to fill the immediate needs of communities. Behavioral health needs typically begin to increase six-months after a traumatic event and continue to increase from that point. DHHS is working to allocate resources accordingly to meet identified and anticipated needs.

Activities

Behavioral health crises tend to increase beginning six months after an incident and into the recovery period. Helene-impacted areas have seen a continued increase in the number of residents seeking mental and behavioral health support. These funds are serving the populations that need it most when they need it most.

Funds are being used to provide services through more than 20 programs, including: counseling services and supports for deaf and hard-of-hearing individuals; transitional housing, employment, and mental health/substance use services for veterans; support for federally qualified health centers to increase the amount of mental health support services they can offer; mobile units to support substance use or misuse treatment; expanded peer support center services; critical incident debriefing and counseling for first responders; crisis services and counseling for children and families; disaster preparedness training for group homes and organizations that support vulnerable populations; critical incident training and stress management for Division of Social Services employees; school-based mental health support; mental health crisis intervention, response, and counseling services; summer trauma recovery camps for children and families; and transition to community living.

As of June 30, 2025, 5,718 individuals have been served by these programs. While a significant portion of the funds has been obligated to local partners through letters of allocation, a lag in the process of invoice submission for reimbursement from the local partners means that the actual expenditures lag.

Department of Health and Human Services

Utility Assistance

Enacting Legislation SL 2024-53

Program Description

This funding is for County Departments of Social Services, in counties with a federal disaster declaration, to provide utility assistance to households who have suffered hardship due to Hurricane Helene and are facing a housing crisis.

Activities

As of June 30, 2025, 9,983 households have received assistance under the program. All remaining funds have been obligated, meaning that local DSS units are processing payments for invoices received and the funds will be expended by the end of July 2025.

Local Health Department (LHD) Support

Enacting Legislation SL 2024-53

Program Description

Funds to assist Local Health Departments in counties with a federal disaster declaration due to Hurricane Helene with restoring essential functions, including temporary staffing, communicable disease and infection prevention efforts, environmental health efforts, and private well water quality efforts.

Activities

All of the \$12 million was allocated to Local Health Departments (LHDs) in the impacted area, and 18 LHDs have accepted funds. As of June 30, 2025, nine LHDs have spent funds to serve a total of nine counties. Most of the expenses have been for staffing, emergency supplies, repairs, and equipment.

The remaining impacted counties declined funds for reasons such as no disruption or little to no impact on essential public health functions, services, or programs. LHDs have until May 31, 2030, to expend the funds and until June 30, 2030, to draw down funds for reimbursement.

Department of Health and Human Services

Child Welfare Essential Services

Enacting Legislation SL 2024-53

Program Description

This program allocates funds to DHHS, Department of Social Services (DSS), to distribute funds to county Departments of Social Services to provide essential services and supports to children involved in the child welfare system who have been impacted by Hurricane Helene. Open to the 39 impacted counties.

Activities

All funding – except 10% of the funds retained by DHHS for administrative costs – has been distributed to county DSS offices. A total of 25 counties have access to funds, and 15 of 25 counties have expended allocated funds. So far, 1,595 households have been served by the program.

These funds have been used to provide funding to replace essential items that children and families receiving child welfare services lost during the disaster and to provide support for children and impacted families that reduces the risk of maltreatment and prevents entry into foster care. FEMA, insurance, and other funds (like community donations) assisted families early on, but more needs are materializing as these resources end or do not come to fruition.

Department of Health and Human Services

Disaster Supplemental Nutrition Assistance Program (D-SNAP)

Enacting Legislation SL 2024-53 & SL 2025-2

Program Description

This program allocates funds to DHHS, Division of Child and Family Well-Being (DCFW), to assist DCFW and county departments of social services in matching federal funds for the administrative expenses incurred in operating D-SNAP. The federal program provides food assistance to low-income households with food loss or damages caused by Hurricane Helene. Federal D-SNAP benefits are estimated to exceed \$200 million.

Activities

A total of \$7,543,585.22 was spent on D-SNAP – 50% state and 50% federal. The funds served 72,703 households with food support following Hurricane Helene.

There will be no further updates to this program or expenditures made. The General Assembly reappropriated \$4 million of these funds to the Department of Commerce for tourism initiatives in SL 2025-02.

Department of Health and Human Services

Activities

As of June 30, 2025, approximately 4,400 interest forms were submitted through the state’s Private Roads and Bridges program online interest portal. Approximately 4,000 site assessments and more than 2,000 cost estimates have been completed by the NC Division of Emergency Management (NCEM).

The assessment process uncovered a significant number of duplicate forms, approximately 1,000 entries so far, meaning approximately 3,000 unique sites are in the state program queue. Duplication occurred because residents served by the same damaged road or bridge all submitted interest forms. NCEM assessments reveal that about half of the entries in the state’s interest form are for private road repair, a quarter are for private bridge repair, and another quarter are for the repair of privately owned pipes and culverts.

Construction has commenced on private bridges damaged by Hurricane Helene. Approximately 15 initial sites have been identified in Yancey, McDowell, and Buncombe counties. These will serve to gauge budgets and timelines for future projects.

SL 2025-26 appropriates an additional \$75 million to Private Roads and Bridges program.

The \$5 million was designated for unmet needs not covered by insurance or other programs. Due to the length of time associated with assessments of FEMA and private insurance coverage, the NC General Assembly reallocated this funding in SL 2025-26 to allow additional flexibility in spending.

Federal Funding

North Carolina has received a total of \$1.6 billion in federal funding as of June 30, 2025. Of these funds, \$1.1 billion of eligibility-based funding has been disbursed or obligated by the Department of Homeland Security Federal Emergency Management Agency (FEMA). Another \$540 million has been disbursed by other federal agencies, including from the U.S. Small Business Administration for home and business loans, the U.S. Department of Labor for unemployment insurance, and the Federal Highway Administration for road repairs. Another \$3.1 billion in federal funding has been awarded to the State of North Carolina but requires additional approval steps before being disbursed to the state.

Awarded Federal Funds Highlights

- \$1.4 billion will be administered by the Department of Commerce Division of Community Revitalization (DCR) from the U.S. Department of Housing and Urban Development (HUD) for the state's single family home repair and reconstruction program. Applications are open, and construction on homes should begin later this summer.
- The City of Asheville received \$225 million in Community Development Block Grant-Disaster Recovery (CDBG-DR), and its plan has been approved by HUD. The plan allocates \$125 million for Infrastructure; \$52 million for Economic Revitalization; \$31 million for Housing; approximately \$11.2 million for Administration; approximately \$3.7 million for Planning; and \$2 million for Public Services.
- NC Department of Transportation (DOT) is preparing an authorization request for the US Federal Highway Administration (FHWA) for approximately \$1.15 billion, in addition to the \$750 million authorization already received. FHWA's Emergency Relief Program provides federal funding to repair federal-aid highways and federal lands roads damaged by natural disasters and catastrophic events. DOT believes there will still be a shortfall of approximately \$1 billion for Helene repairs that will need to be filled with state and federal funding.
- NC Department of Environmental Quality (DEQ) is administering \$685 million from the Environmental Protection Agency (EPA) to repair wastewater treatment and drinking water facilities.

American Relief Act Funds

In December 2024, Congress appropriated funds for Helene recovery to the state through HR 10545, [*The American Relief Act of 2025*](#) (ARA). In February 2025 the state estimated its

expected allocation from the ARA to be approximately \$5.95 billion. As of June 30, 2025, the state is still waiting for federal agencies to disburse \$4.2 billion of these appropriated funds to NC agencies. Federal funding disbursement delays have impacted state agency timelines for several major recovery components. For example, the timeline for private property debris removal and demolitions has lengthened because of slow and inconsistent disbursements from the U.S. Department of Homeland Security. In addition, as of June 30, 2025, the U.S. Department of Health and Human Services (USDHHS) had not opened the application period for the Child Care and Development Block Grant (CCDBG) which provides one-time disaster grant funds to child care providers, centers, homes, and Pre-K sites. Congress appropriated \$250 million for the CCDBG in HR 10545, [*The American Relief Act of 2025*](#).

Additional Congressional Appropriations Requested

North Carolina requested Congress appropriate an additional \$11.6 billion in federal funding to address unmet recovery needs, including critical investments in child care infrastructure, child welfare programs, landslide hazard mapping, flood reduction, and water infrastructure projects. Although the state has invested \$2.9 billion of its own funds, this amount combined with federal assistance received thus far still pales in comparison to the estimated total damage of \$59.6 billion. Western North Carolina communities require additional federal assistance to achieve a comprehensive recovery.

Eligibility-Based Programs

FEMA's Individual Assistance (IA), Public Assistance (PA), and Hazard Mitigation Grant Program (HMGP), as well as the programs at the Small Business Administration (SBA) and Department of Labor (DOL), are eligibility-based programs and do not require stand-up of new programs or funding sources. They do require the state to invest alongside the federal government by matching a portion of the funding received. To date, North Carolina has appropriated \$331 million in state match funds.

Of the 100 counties in the state, 39 are eligible for FEMA Individual Assistance (IA) and 26 are eligible for all categories of FEMA public assistance (FEMA Public Assistance Categories A-G).

Hazard Mitigation Grant Program

The state expects to receive about \$1.4 billion from the FEMA Hazard Mitigation Grant Program (HMGP) to reduce the long-term risks to people and property from future disasters. The program provides grants to state, local, tribal, and territorial governments to implement cost-effective measures that seek to minimize disaster damage, enhance community resilience, and reduce reliance on federal disaster assistance. Eligible projects include infrastructure improvements, property acquisition, flood risk reduction, and community planning. So far, the state has received an initial \$16.3 million for its management costs. The state is working with counties to batch and submit applications to FEMA on a rolling basis. As of June 30, 2025, nine applications for acquisition were submitted to FEMA covering 181 residential properties. An additional nine applications for acquisition were being finalized to submit to FEMA, representing 249 properties.
